Vice Chair Kenning moved, seconded by Supervisor Parker to approve the minutes of the July 14, 2015 Board meeting. Motion carried.

Total	One hundred twenty-two (122) votes

We therefore declare Bill Hinshaw to be elected for the residue of the term, ending November 2015 and until a successor is elected and qualified.

City of Blakesburg  
Council Member (To fill a vacancy term ending November 2015)

Robert Chisman	received one hundred two (102) votes
Phillip Cormeny (write-in)	received seventeen (17) votes
Scattering	received two (2) votes
Total	One hundred twenty-one (121) votes

We therefore declare Robert Chisman to be elected for the residue of the term, ending November 2015 and until a successor is elected and qualified.

City of Blakesburg

Council Member (To fill a vacancy term ending January 2018)

Cindy DeWild	received one hundred eleven (111) votes
Scattering	received six (6) votes
Total	One hundred seventeen (117) votes

We therefore declare Cindy DeWild to be elected for the residue of the term, ending January 2018 and until a successor is elected and qualified.

Supervisor Parker moved, seconded by Vice Chair Kenning to accept the Canvass as presented. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to approve the service contract renewal with Solutions. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Kenning to approve a request to hire Marilyn Richards as a temporary Clerk in the Veteran Affairs office to fill hours left from vacancy, hire date 7/1/15 at an hourly rate of \$10. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to accept and file the Treasurer's Investment Report for June 2015 and the Semi-Annual Report 1/1/15 through 6/30/15.

County claims in the amount of \$679,276.76 and payroll in the amount of \$314,764.21 were approved. Handwritten check in the amount of \$902.72 to U.S. Treasury, claim #12493, was approved.
