CANVASS OF MARCH 2, 2021 SPECIAL SCHOOL ELECTION:

For Public Measure "A" Ottumwa Community School District

For the question, there were Six Hundred Ninety-Three (693) votes

Against the question, there were Three Hundred Fifty-Eight (358) votes

Total One Thousand Fifty-One (1051) votes cast.

We therefore declare Public Measure "A" to be adopted.

Supervisor Morgan moved, seconded by Vice Chair Parker to accept the Canvass as read. Motion carried.

For Public Measure "B" Cardinal Community School District

For the question, there were One Hundred Ninety-Seven (197) votes

Against the question, there were One Hundred Forty (140) votes

Total Three Hundred Thirty-Seven (337) votes cast.

For Public Measure "C" EBF Community School District

For the question, there were One Hundred Forty-One (141) votes

Against the question, there were One Hundred Eight (108) votes

Total Two Hundred Forty-Nine (249) votes cast.

For EBF DD #6 (To Fill A Vacancy)

Patti Maloy received Forty-Seven (47) votes

Gary Collett Jr (Write In Candidate) received Two (2) votes

Scattering received Three (3) votes

Total Fifty-Two (52) votes cast.

We therefore declare Patti Maloy duly elected for the office of EBF DD #6 for the remainder of the term.

Supervisor Morgan moved, seconded by Vice Chair Parker to accept the Canvass as read. Motion carried.
