Chair Huit opened the meeting. Supervisor Morgan moved, seconded by Vice Chair Parker to approve the agenda. Motion carried.

Vice Chair Parker moved, seconded by Supervisor Morgan to approve the minutes from the May 18, 2021 board meeting. Motion carried.

PUBLIC HEARING – CDBG 20-OT-061 Wapello County Emergency Relief Food Program. Supervisor Morgan moved, seconded by Vice Chair Parker to open the public hearing. Motion carried. There were no written or verbal comments. Vice Chair Parker stated that because of the virus seniors are more hesitant about going out in public, with the county providing a second food box it would reduce the need for food box recipients to go out in public. He also stated the grant was what would assist in paying for the second free food box to seniors each month through June 30, 2021. The amount of CDBG funds for the project are \$8,636.00. Vice Chair Parker also stated that the Food Bank of Iowa was assembling and delivering the food boxes from 705 W Main St, Ottumwa, Iowa. No relocation will occur and it is not a construction project. If residents have concerns or complaints regarding this project they can contact Vice Chair Jerry Parker. Supervisor Morgan moved, seconded by Vice Chair Parker to close the public hearing. Motion carried.

Vice Chair Parker moved, seconded by Supervisor Morgan to approve bid from Eldon Louwsma for Kirkville Wildlife Area. Motion carried.

Supervisor Morgan moved, seconded by Vice Chair Parker to approve a Cigarette/Tobacco/Nicotine/Vapor license for Rocket Fuels and Food Mart, effective 7/1/2021 to 6/30/2022. Motion carried.

Supervisor Morgan moved, seconded by Vice Chair Parker to approve a Cigarette/Tobacco/Nicotine/Vapor license for Elliott Oil Company, Highway 63 South BP for 7/1/2021 to 6/30/2022. Motion carried.

Vice Chair Parker moved, seconded by Supervisor Morgan to approve Nyhart contract for Interim GASB75 Report for fiscal year ending June 30, 2021. Motion carried.

Supervisor Morgan moved, seconded by Vice Chair Parker to appoint Larry E. Patrick to the Wapello County Planning and Zoning Board. Motion carried.

Supervisor Morgan moved, seconded by Vice Chair Parker to approve change of payroll for Miguel Torres from CO1 to Deputy Sheriff effective 6-7-2021. Motion carried.
