Vice Chair Kenning moved, seconded by Supervisor Parker to set the date of April 17 at 9:30 a.m. for a public hearing on plans and specifications on the Courthouse boiler project. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to set the date of April 26 at 2:00 p.m. for accepting bids on the Courthouse boiler project. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to accept and file the Treasurer's Investment Report for February 2012. Motion carried.
