PUBLIC HEARING ON A CONSTRUCTION PERMIT APPLICATION FOR A CONFINEMENT FEEDING OPERATION IN SECTION 5, COMPETINE TOWNSHIP. No written comments were received.

Kent Krause, Pinnacle in Iowa Falls, said he'd prepared the permit for the Sterling family. The confinement feeding operation is to be a 4960 head site, two buildings with pits between the buildings and a total slat floor. This sits in the middle of a field owned by the Sterling family, is over 3400 feet from the next neighbor and over 2200 feet away from any water source. It's over 3400 feet away from a cemetery. All 520 acres owned and operated by the family score on the very best phosphorus scale. He said the acres can handle the manure.
