Supervisor Siegel moved, seconded by Vice Chair Parker to approve hiring Codie Anderson as a new part-time Correctional Officer I in the Sheriff's department, hire date 2/22/16 at an hourly rate of \$13.00. Motion carried.

Supervisor Siegel moved, seconded by Vice Chair Parker to set the date of March 1<sup>st</sup> at 9:30 a.m. for a public hearing for closing and vacating Marion Street in the unincorporated city of Highland Center. Motion carried.

Rich Gaumer, Chair of the Compensation Commission, addressed the Board with their recommended salary increase for elected officials for fiscal year 2016/2017. Following discussion, Supervisor Siegel moved, seconded by Chair Kenning to reduce the Comp Board's recommendation by 2/3 making it a 2.0% increase with a 1.0% increase for the Board of Supervisors. Motion carried on a 2 to 1 vote.

Vice Chair Parker moved, seconded by Supervisor Siegel to approve a tax suspension under Iowa Code 427.9. Motion carried.

Supervisor Siegel moved, seconded by Vice Chair Parker to accept and file the Clerk of Court's monthly report of fees collected 1/1/16 through 1/31/16. Motion carried.
