Chair Morgan opened the meeting. Vice Chair Kenning moved, seconded by Supervisor Parker to approve the agenda. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to approve the minutes of the August 7, 2018 Board meeting. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Kenning to approve the renewal for Document Locator for the auditor's office. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to approve to extend the employment contract with Brian Moore effective from July 28, 2018 - October 5, 2018. Motion carried.

Discussion on building inspector for the City of Kirkville. County building inspector doesn't think that an agreement is needed at this time between the county and the City of Kirkville. The county building inspector will help out on an as needed basis. In six months they will review the situation. If it starts to burden the building inspector then an agreement will be drawn up and a fee charged.

Edward Koetsier addressed the board with concerns regarding 18th Ave in Eldon, IA and the dust issue on the road. If the dust can't be controlled, he would like for the county to quit laying rock on the road and to leave the road alone. Supervisor Parker stated that the secondary roads dept. has been working since April on getting the roads in better shape for the future.

Donna Gravett addressed the board with a concern regarding Bluegrass Rd. and the amount of wrecks on the corner by her residence. She would like for an engineer to look at the curve/corner to see if there can be any safety measures put in place to make the road safer. The county engineer will look into the matter and see what safety measures can be taken, if any.

Marilyn Walker, Mayor of Kirkville, addressed the board regarding the two main roads coming into Kirkville, which are Main and Cedar Streets in front of city hall. They are in need of some gravel on the edges of the road. Supervisor Parker will look at the 28E agreement between the county and the City of Kirkville, but ultimately the county will help in any way that they can.

Claims in the amount of \$542,599.73 and payroll in the amount of \$295,103.06 were approved.
