Vice Chair Morgan moved, seconded by Supervisor Huit to approve changes in policy in the Wapello County Handbook. The current Handbook Language permits a retiring employee the option to be paid 45% of his or her outstanding sick leave. Language in the Handbook is changing to reflect the actual practice which permits only an employee with 15 years or more of employment with Wapello County to be eligible for this benefit. Therefore, it is the policy of Wapello County that a retiring employee who has been an employee of the County for 15 years or more, has the option to be paid forty five percent (45%) of the value of his or her accumulated sick leave as of the day of his or her last day of employment. Motion carried.

Vice Chair Morgan moved, seconded by Supervisor Huit to accept and file the Auditor's FY 18/19 Cash Report. Motion carried.

Vice Chair Morgan moved, seconded by Supervisor Huit to accept and file the Auditor's 4th Quarter Cash Report for FY 18/19. Motion carried.
