- For odometer certification errors
- To nullify the bona fide sale and delivery of a vehicle for reasons including, but not limited to, repurchase offers or failed financing.

1. This affidavit can only be used to correct the errors identified.
2. All signatories to the original error, erasure, or alteration must sign this affidavit.
3. This completed affidavit must be notarized and attached to the document that contains the error.
4. Facsimiles and photocopies are not acceptable.
