Supervisor Parker moved, seconded by Vice Chair Kenning to approve request to hire Colton Harry as COI in the Sheriff's Office starting 8-13-2018 at \$17.25 per hour. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to approve request to hire Kristi Goodson as Clerk 1 in the Treasurer's Office starting 8-20-18 at \$12.22 per hour. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to acknowledge the hire of Courtney Cobler as part time Home Health Aide in Public Health starting July 30, 2018 at \$10.25 per hour. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Kenning to approve the change of employment for Angela Malone from Clerk II to Clerk III effective 8-1-2018 at \$16.29 per hour. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Kenning to acknowledge the hire of Michael McCall as Conservation Technician at County Conservation starting 8-14-18 at \$35,191.53 per year. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Kenning to approve 2018 Justice Assistance Grant Award for \$1,555.00 a partnership with the City of Ottumwa. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to approve Interlocal Agreement between the City of Ottumwa and Wapello County for the 2018 Justice Assistance Grant (JAG) Program. Motion carried.

Vice Chair Kenning moved, seconded by Supervisor Parker to approve temporary closure of 150th St for Fly Ottumwa from approximately 4-11 on Friday, August 24 and 12-8 on Saturday, August 25, 2018. Motion carried.

Supervisor Parker moved, seconded by Vice Chair Kenning to approve Resolution #36-2018 to compromise certain property taxes in Wapello County. Motion carried.
