Ed McDowell asked about the increase of 32% vs the 2% increase. Christy Lee 30 Greenbriar asked what the board was doing to make changes, she lives in the County but does not drive on county roads. Marilyn Russ of 13792 85th Ave. guestion 3.50 levy from the City, it was clarified that this is a County levy rate, she has also faced increases in the value of their property. Mark Stevens is frustrated with the recent assessment. Landon Allen of 17 Bear Creek Dr stated he moved to the County to avoid the high taxes in the City, but it appears he will be paying higher taxes in the County. Stacy Gray has a fear of losing her home if increases continue to happen. Connie Hamersley-Wilson asked where Rep. Wilz & Westrich were at, she felt they should be there to hear the concerns. Christian Schrock questioning on who decided to raise the levy rate, its not the state who raised the levy rate it is the county who raised the levy rate. John White full-time farmer stated his taxes and insurance has went up 4 times since he owned his property.
